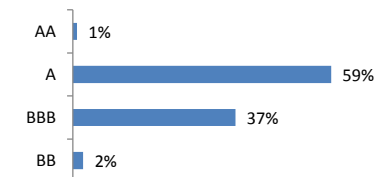
Recommended investment horizon
