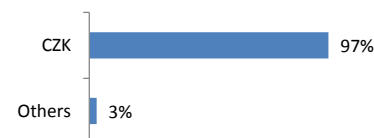

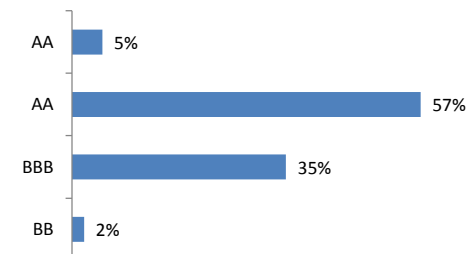
Recommended investment horizon
