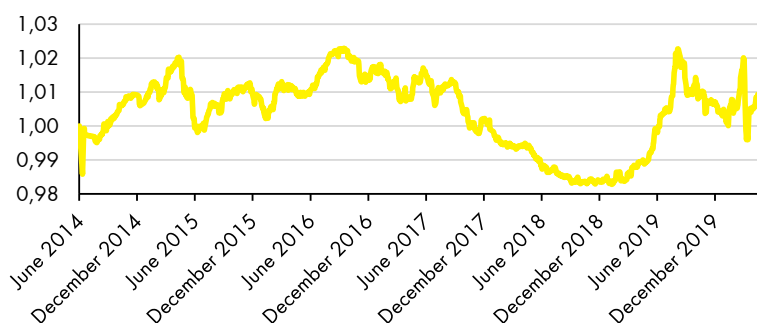

- The investment is associated with interest rate, currency and concentration risks

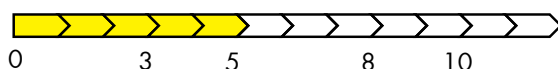
